The Ninilchik Village Tribe is a federally recognized tribe in Alaska, consisting of approximately 1,100 members. These members can trace their ancestry to Ninilchik tribal lands or are Alaska Natives and American Indians who have settled within the tribal boundaries and have been accepted for membership. The Tribe is governed by the Ninilchik Traditional Council, composed of five elected council members who serve three-year terms. They oversee tribal operations and uphold sovereignty using Organic Documents approved by the tribal membership.

Executive Director's Address

**Happy summer!**

I hope your gardens are growing well and the fish are plentiful. Sadly, and once again, the Cook Inlet eastside commercial setnet season is closed, and the educational fishery didn't start until July 1st. The educational fishery seems to be doing slightly better than last year. This does, however, pale in comparison to the federal subsistence gillnet fishery in the Kasilof River, which harvested 1,665 sockeye salmon for the Ninilchik community. This is down from our highest catch on record, which was last year. The Resource Department is now moving to the Kenai River. We've received over 150 community household permits, representing a total of around 4,775 fish. We still anticipate that the crew will be able to fulfill the remaining permits on the Kenai River; however, nothing is guaranteed.

The work on our Tribal 8(a) company, Tuyan, LLC (Tuyan), is continuing to go very well. Our General Manager, Tomia Taylor, along with our amazing staff, are doing positive work with the Defense Logistics Agency (DLA). We have been notified that our Option Year 3 with the DLA was approved with a modified staffing plan. This will add three direct hires to the Tuyan side and continue our strong partnership with Great Northern Engineering. We are anticipating a roughly \$500,000 net profit this year as well. Greg and I recently participated in a strategic planning session for Tuyan, in which we are looking to acquire another successful company to add additional commercial services to our business and continue the growth.

The Council is continuing to work hard on the cultural heritage center planning. We recently received the Fire Marshal permit for the building, along with other permits that are necessary for construction. The Tribe is waiting on a wetland delineation from a contractor so we can submit the permit requirements to the Army Corps. This is a large undertaking. Work is also being done to acquire the additional property that will be necessary for the project, which is adjacent to the current lot that the Tribe owns. Cook Inlet Tribal Council (CITC) recently finalized the donation of the 11 acres on the hill, which will make our ownership contiguous and fulfill the needs for the facility and expansion opportunities. We are eternally grateful to CITC for this donation.

This summer, we have ten youth working for the Tribe doing summer youth internships. These positions range from working in our Admin department to assisting at the Health and Wellness Club, as well as the Elders program. It is once again so great to see our youth working and engaging with the Tribe.

I want to take a moment to recognize and thank Dean Kvasnikoff for his amazing service to our Tribe. He has served on the Council for many years as your Vice President. His commitment and dedication to the growth and expansion of NTC has been so profound. He recently stepped down from the Council to concentrate on his health, and we wish him all the best. I can't express how grateful I am for the time and expertise he gave to us. As the seat was vacant, the Council is required by the constitution to appoint an eligible Tribal Member to the position, in which Lorita Van Sky was selected to fill the vacancy. Lorita has served on the Council in the past, and we welcome her service and look forward to her expertise and leadership.

Happy summer, and may your fishing and harvests be plentiful and blessed! Thank you.

Hello Ninilchik Tribal Members,

I hope everyone had a wonderful 4th of July and are off to a great Summer! It's been a slow starting one, but overall, the weather has been nice since the end of June.

We are in the final phase of the Environmental Review, which are the first steps to being able to purchase the land that we will build our next home upon. Believe it or not this will be our 26th home that we have built!

The Homeownership Program is one of our most popular programs for young families wanting a firm leg up in life by owning a home. The youth of today seem to have less opportunity for a chance at home ownership. This is an amazing investment that the Tribe is providing for its eligible young families. If all goes well by this next newsletter, I will have pictures of the progress of the construction for you to look at, *and* if all goes well with the construction, the eligible family should be able to move into the home around the first of January. We know how to start our family's New Year's off right. :)

This is the time to get your applications in for the Weatherization Program. Remember all those cold spots on your floors or cold air coming from your windows and doors. This is the time to get it all done. While it's warm outside. Think about what needs to be done to make your home more efficient and then make a list. Prioritize that list of projects by which ones will add the most comfort, heating, and energy efficiency to your home. Then go to our website and download the application or come by the office and pick one up. There is a \$2,000 limit, and you will be responsible for having the work done. With these programs you can reapply every five years. If you have questions, please feel free to call, email or come by and we can see what the best way is of going about what you are wanting to do.

There are a few people that are needing a little help, so I urge those people to look at our Emergency Assistance Program. All these programs we offer can be found on the Tribe's website under Housing. All programs give brief explanations and downloadable applications. Take a look and see if it might help you out, and if you still have questions, please feel free to call or email for advice.

Until the next newsletter, take care of you and your families, stay healthy, and have a wonderful rest of this great summer. And of course, all with lots of fish and bountiful gardens!

HEALTH UPDATES

To improve accessibility, the Homer Clinic recently installed a wheelchair lift, which will be fully operational by early August.

We're excited to welcome some new faces at the front desk! Denise Whitacre and Heather Smith have joined us, stepping in for Dugan and Victoria as they begin training for their new roles as medical assistants.

In April, Dr. Mathew Clark, Acting Deputy Chief Medical Officer for IHS and Chief Medical Officer for the Alaska Area Native Health Service, visited our clinic, met with patients, and joined the MOUD team in the mobile van.

An NPR article titled *'Here's one thing Alaska could do to reduce opioid overdose deaths'* highlights the impactful work of Dr. Spencer and Annette through their MOUD (medications for opioid use disorder) program. They travel weekly between Homer and Nikiski (Salamatof grounds), stopping south of the Kasilof River, to see 15–25 patients each visit via our mobile clinic.

This program has grown significantly, and nearly all of our providers now contribute to the care of these patients.

BEHAVIORAL HEALTH

At NTC Behavioral Health, our mission is to provide the highest quality of care to help individuals reach their self-determined goals. We offer integrated mental health and substance use treatment in a supportive, compassionate, and culturally responsive environment; always focusing on each person's unique strengths.

We are proud to offer behavioral health services across NTC's three medical clinics in Ninilchik, Anchor Point, and Homer. In addition, we've expanded our reach through a meaningful partnership with the Ninilchik School, where we provide on-site behavioral health services to students. Families can also access clinical services for their children through the school, making it easier to receive care in a familiar and convenient setting. Our school-based services include classroom support focused on social-emotional learning and the facilitation of the Sources of Strength Peer Leader group, empowering youth to foster resilience, connection, and hope. We also offer telehealth options for those who prefer remote access to services.

Our Behavioral Health team is made up of compassionate and experienced professionals who provide a wide range of services to individuals and families. Each clinician brings unique strengths and specialties—from youth and family therapy to substance use counseling and trauma-informed care—ensuring our community receives well-rounded, personalized support.

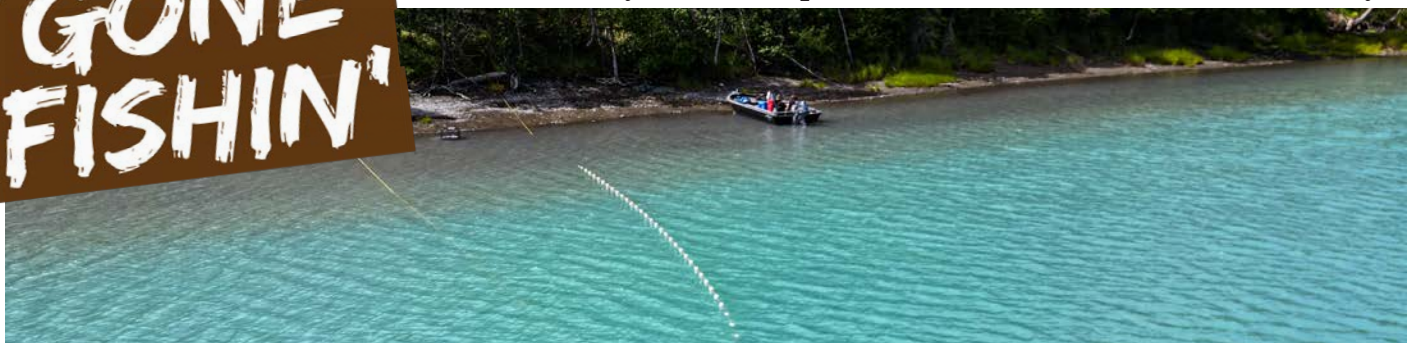
We're excited to welcome Morgan Dwyer, M.A., LPC to our Behavioral Health team. Morgan joined us in January and brings specialized experience working with children ages 3–10. Her approach not only supports young children through early developmental and emotional challenges, but also uplifts parents and caregivers through individualized coaching, education, and early intervention strategies. Morgan is also trained in substance use treatment, prevention, and intervention sciences, and is able to accept Medicare coverage.

This winter, our team hosted a community clothing drive, and thanks to your incredible generosity, we now have a Clothing Closet available at the Ninilchik Clinic. Open Monday through Friday 9:00am-5:00pm, the closet offers clothing for anyone in need of a little extra support.

Early Learning Program

The Ninilchik Traditional Council's Early Learning Program (ELP) will begin student registration in September, with classes starting in October. This program is designed to give pre-elementary children opportunities to socialize with peers, engage in group activities, and explore age-appropriate learning experiences in a supportive and nurturing environment. Our goal is to foster a positive foundation for lifelong learning and to support early childhood development within our community.

NTC Higher Education Scholarship

NTC offers a Higher Education assistance program for Alaska Native and American Indian students who are enrolled Tribal Members of Ninilchik. This funding is available to students who are attending a four-year accredited college or university full-time (minimum of 12 credits) and demonstrate unmet financial need.

Eligible students may receive financial support to help cover tuition and fees.

The Elders Outreach Program's Luncheon exists to serve as a social space for Enrolled Tribal Elders to gather, share, and visit. Elders are welcome to bring a guest, family member, or caregiver, if they wish. A donation box will be available at the back for this purpose. While it is a provided luncheon for Enrolled Tribal Elders to attend, it also serves many homebound Enrolled Tribal Elders who cannot drive or have other needs that prevent them from attending. The luncheon is also for these Elders, and we ask that all be mindful of others who are not able to attend, as any additional food will be provided and delivered to their homes.

Craft Wednesdays

The Elders Outreach Program began a weekly crafting class on Wednesdays of each week in February of 2024. Whoever attends has a chance to include ideas, options and suggestions to the group for crafting together on projects. Though, one could attend and primarily work on a project they would like to do, but do not have a sewing machine or other tools we provide here. Over this past year, the group has made jewelry, home goods, cultural pieces, painting projects, and baked goods. If you would like to attend or have questions, please reach out to us.

Many of you have asked about our LFPA Plus Grant and our OAA grants, both of which continue at normal operating funding. We have not had any funding cut due to changes in the Federal Administration. We also ended up preparing for a new grant cycle with the Administration on Aging as well as extending our deadline to the LFPA Plus. Last year we acquired a \$10,000 grant for operating in the EOP from CIRI. We reapplied recently and have heard this year is also a blessing for our program. Thank you, CIRI. I would also love to give the biggest shout-out to NTC for hiring Tristan Goodman! What a butcher! Thanks to all his continued help in the EOP for processing larger primals into more manageable cuts for everyone.

I would be remiss to leave out thanking and acknowledging Jessica Haddock's continued work here in the Elders Program as well. Jessica's attention to detail, companionship, and connection to the Elders in our community has not gone unnoticed, and many Elders have mentioned how valued they feel by her. These traits cannot be trained; they are instinctual and an asset to our program. We are all so grateful for her arduous work here. *Psst – she's an awesome butcher too!

Thank you to NTC, Darrel Williams, and his team at the Resource Department for all their work on the Subsistence Gill Net Fishery. Jessica and I have thoroughly honed our fillet skills once again and have been blessed to help with processing community members' salmon. The continued fight for subsistence rights has been, and will continue to be, a legacy of our Executive Director, Ivan Encelewski, who has fought for our Tribal members' Indigenous ways of life, rights, and culture.

It wouldn't be possible without the LFPA Plus grant that many of the vendors, fishermen, agriculturists, farmers, and our program could flourish cohesively. This year we have once again been able to supplement salmon from Jeff Ambrosier. Thank you so much, Jeff! It may seem odd for a Tribe to have to reach out to a fisherman; however, the restrictions in our current area prevent us from being able to harvest the species our Elders have survived on for generations.

Thank you as well to Seabury Farms, Sunna Ridge Farm, and Secret Garden, who have worked with us on providing fresh produce, quail eggs, duck eggs, chicken eggs, and a variety of proteins.

The Elders Outreach Program acknowledges **William "Dean" Kvasnikoff** for his support, guidance, and advocacy over the years, serving as a Council member of our governing Board at Ninilchik Tribe. Dean's drive for our people's rights on our land, subsistence traditions, and our future generations has been mighty over the years, and we honor his wisdom. 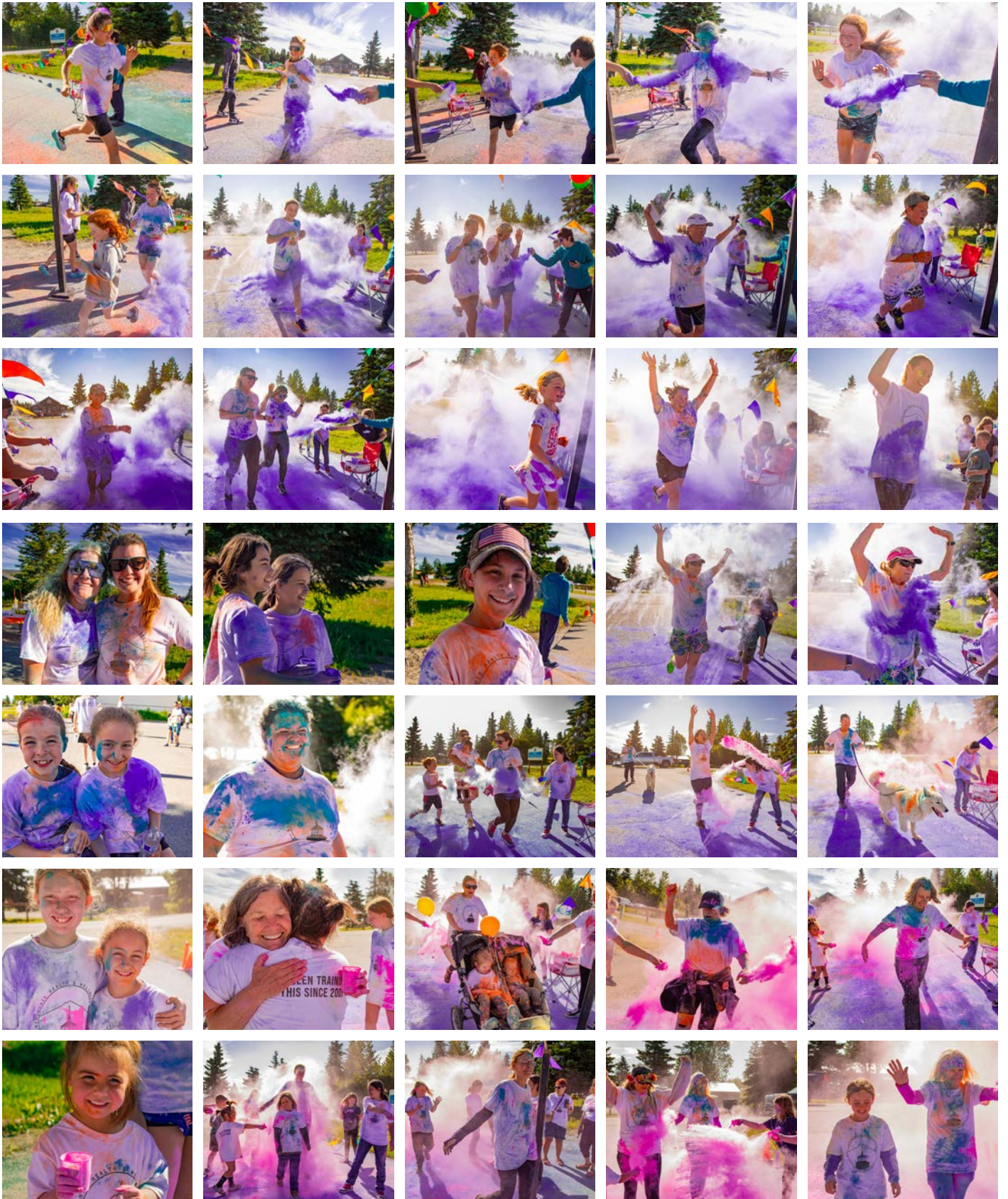

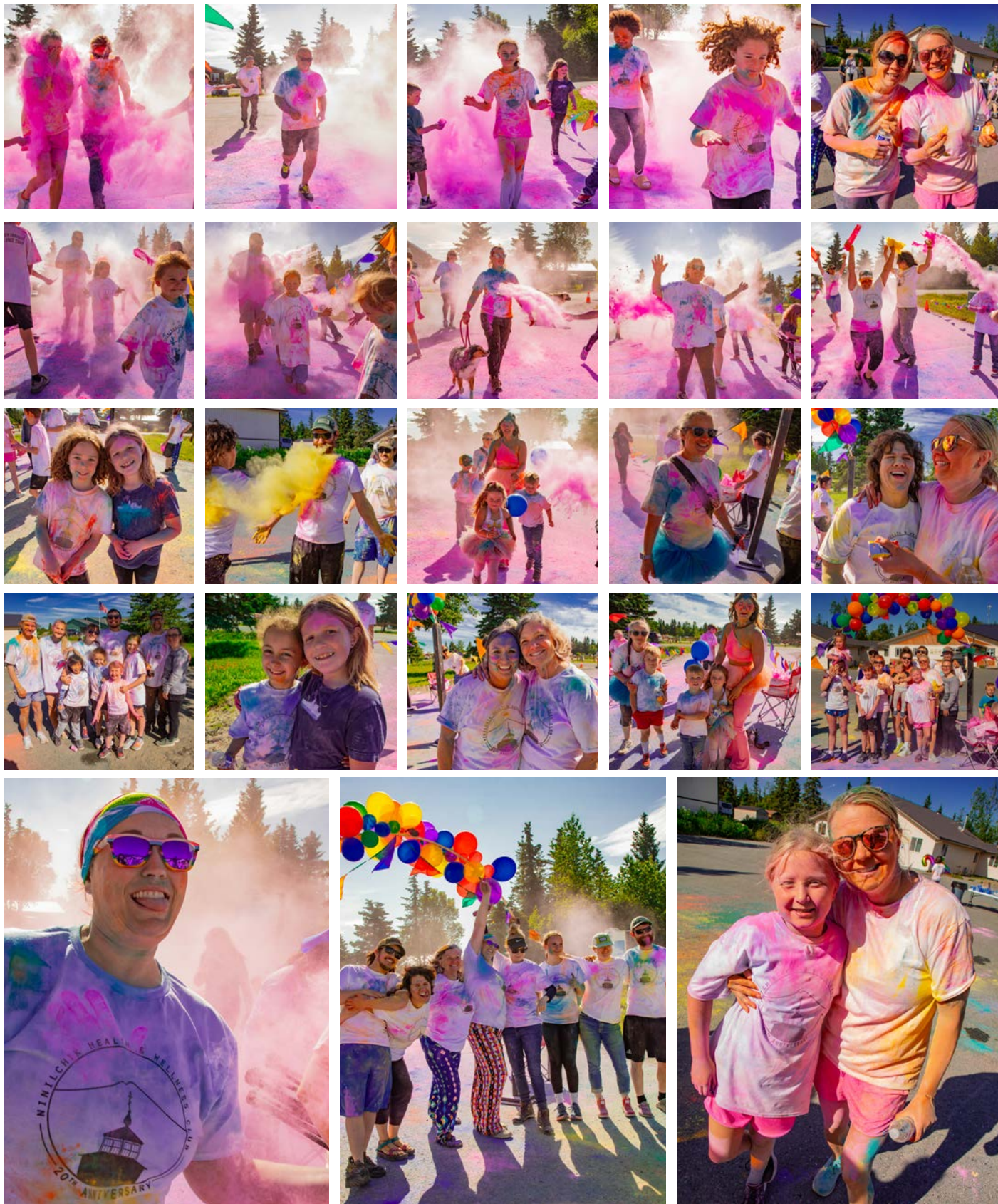

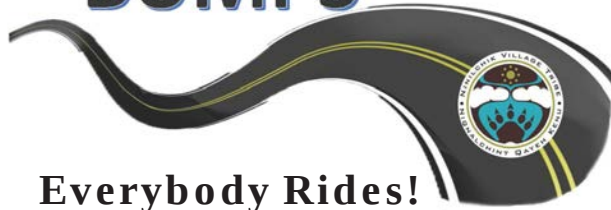
